



A BILL FOR AN ORDINANCE

RELATING TO SPECIAL TRANSIT SERVICE.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this ordinance is to clarify the provision of supplemental special transit services for persons requiring special transit services for medical reasons.

SECTION 2. Section 13-4.1, Revised Ordinances of Honolulu 1990, is amended to read as follows:

"Sec. 13-4.1 Authorization.

The department shall provide a special transit service and establish policies and guidelines for its operation. The policies and guidelines shall conform to the short range transit plan and any update. The department shall contract the private, nonprofit corporation established under Article 8 to manage, operate, and maintain the special transit service on behalf of the city. The department shall also contract with private entities as required by Section 13-6.2."

SECTION 3. Section 13-6.2, Revised Ordinances of Honolulu 1990, is amended to read as follows:

"Sec. 13-6.2 Contracts for management, operation and maintenance of city bus system, special transit service [and/or] and supplemental services.

- (a) The department shall contract with the private, nonprofit corporation established under Article 8 to manage, operate, and maintain the city bus system and the city special transit service on behalf of the city. The corporation shall not, however, provide special transit services to transport individuals to doctor's offices, hospitals or other medical facilities.
- (b) The department may contract with private entities, including the private, nonprofit corporation established under Article 8, to manage, operate, and maintain the supplemental bus service [and supplemental special transit service] on behalf of the city.
- (c) The department shall contract with private entities, but not with the private, nonprofit corporation established under Article 8, for supplemental special transit services to transport individuals to doctor's offices, hospitals and other medical

facilities. The private entities providing these services must be licensed to provide these services.

- (d) The department may contract with either the private, nonprofit corporation established under Article 8 or other private entities to provide supplemental special transit services to destinations other than those enumerated in subsection (c)."

SECTION 4. New ordinance material is underscored and ordinance material to be deleted is bracketed. When revising, compiling, or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the revisor of ordinances need not include the underscoring, the brackets, or the bracketed material.
