WHEREAS, through a letter from the Director of the Department of Parks and Recreation requesting acceptance of a gift to the Council and approved by the Managing Director in the amount of \$6,383.78 (Six Thousand Three Hundred Eighty-Three and 78/100 Dollars) from the Honolulu Marathon Association is for Kapiolani Regional Park; now therefore,


