



RESOLUTION

RELATING TO THE TRANSFER OF FUNDS

WHEREAS, Section 2-17.2 (c)(1), of the Revised Ordinances of Honolulu 1990, as amended, requires that the Honolulu City Council approve by resolution any transfer of funds between activities whenever the cumulative amount of transfers from or to an activity totals in excess of \$100,000 or ten percent of the amount appropriated for that activity in the operating budget ordinance, as may be amended, whichever is less; and

WHEREAS, a transfer of \$256,000 is required to meet the salary needs of the Honolulu Fire Department's (HFD) uniformed personnel as required by their collective bargaining agreement; and

WHEREAS, a transfer of \$180,000 from the HFD Fire Operations is required to meet manpower coverage at our Mechanic Shop; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that \$436,000 be transferred between the following activities:

BE IT FURTHER RESOLVED that the Mayor of the City and County of Honolulu or his designee is hereby authorized to carry out the provisions of the Resolution; and


