



This is especially significant toward encouraging agricultural producers, processors, and value-added agriculturally-based product entrepreneurs to expand their initiatives and capacities. Key outcomes include increased food sustainability, safety and supply; in addition to increased numbers of agriculturally related job opportunities. These outcomes are congruent with the State of Hawaii's constitutional mandate to protect agricultural lands, promote diversified agriculture and increase the State's ability toward achieving a higher level of self-sufficiency.

Importantly, in addition to the State's income tax credits, temporary General Excise Tax and workers' compensation premium exemptions, the proposed incentives for eligible businesses in the newly designated EZ for rebates of real property taxes on all new construction (for a period not to exceed two years); and, a waiver of fees for building and grading permits for new construction for a period of seven years will only serve to spur further agricultural businesses' economic development and growth in our North Shore, Wahiawa and Mililani communities.
