



RESOLUTION

RELATING TO THE APPOINTMENT OF LORETTA A. SHEEHAN TO SERVE ON THE POLICE COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-1605, Revised Charter of the City and County of Honolulu, 1973 ("RCH"), as amended, establishes a Police Commission consisting of seven members appointed by the Mayor and confirmed by the Council; and

WHEREAS, the major duties of the Police Commission are:

- (1) Adopt such rules as it may consider necessary for the conduct of its business and review rules and regulations for the administration of the department;
- (2) Review the annual budget prepared by the Chief of Police and make recommendations to the Mayor;
- (3) Submit an annual report to the Mayor and the City Council;
- (4) Receive, consider and investigate charges brought by the public against the conduct of the department or any of its members and submit a written report of its findings to the Chief of Police;
- (5) Review and, if deemed necessary, make recommendations on the Police Chief's five-year plan and any update of the Chief's goals and objectives for the police department;
- (6) Compare at least annually the actual achievements of the police department against the goals and objectives of the five-year plan or latest update; and
- (7) Evaluate, at least annually, the performance of duties by the Chief of Police;

and

WHEREAS, by Mayor's Letter, dated June 3, 2016, the Mayor has appointed Loretta A. Sheehan to the Police Commission; and

WHEREAS, if confirmed by the Council, Ms. Sheehan will succeed Helen H. Hamada whose term expired on December 31, 2014, and will serve for a term which expires on December 31, 2019; and


