



RESOLUTION

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution No. 05-349 CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter from the Director of the Department of Parks and Recreation has submitted a request for acceptance of a gift to the Council and approved by the Managing Director of a monetary gift of \$4,118.35 (Four Thousand One Hundred Eighteen and 35/100 Dollars) for the maintenance of Ala Moana Regional Park and McCoy Pavilion; and

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift of cash in the amount of \$4,118.35 (Four Thousand One Hundred Eighteen and 35/100 Dollars) from Shinnyo-en Hawaii that is more fully described in the above-mentioned letter from the Director of the Department of Parks and Recreation and the Declaration of Gift attached as Exhibit A; and






