



RESOLUTION

AMENDING RESOLUTION 15-116, CD1, TO EXTEND THE DEADLINE FOR THE DEPARTMENT OF ENTERPRISE SERVICES TO SUBMIT A REPORT OF THE FINDINGS AND RECOMMENDATIONS OF THE HONOLULU ZOO WORKING GROUP.

WHEREAS, on June 3, 2015, the Council adopted Resolution 15-116, CD1, which found that it is imperative to explore and examine approaches to maintain and promote the growth of the Honolulu Zoo ("Zoo") and address policy issues facing the Zoo in the short- and long-term so as to ensure that visitors to the Zoo and residents alike enjoy the Zoo for years to come; and

WHEREAS, Resolution 15-116, CD1, also requested that the Department of Enterprise Services ("DES") form a working group to:

- 1) Discuss policies to maintain and promote the growth of the Zoo;
- 2) Address significant issues facing the Zoo in the short- and long-term; and
- 3) Formulate specific short- and long-term recommendations regarding City policies for action by the Council in its legislative role and its role as Trustees of the Kapiolani Park Trust for purposes of ensuring the future sustainability, growth, and viability of the Zoo; and

WHEREAS, the Resolution further directed the DES to report the working group's findings and recommendations to the Council within 210 days after adoption of Resolution 15-116, CD1, which was December 30, 2015; and

WHEREAS, to date, no report has been received by the Council; and

WHEREAS, the Council desires to extend the deadline for the DES to submit its report; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Resolution 15-116, CD1, is amended by extending the deadline for the DES to submit the report of the working group's finding and recommendations to the Council from December 30, 2015, to within 90 days after adoption of this Resolution; and




