WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council;

WHEREAS, through a letter, the Director of Customer Services has submitted a request for acceptance of a gift to the Council and approved by the Managing Director for the acceptance of used modular furniture valued at \$5,000 (estimated depreciation value) from the Daniel K. Inouye Elementary School for use by the Department of Customer Services, Division of Motor Vehicle, Licensing and Permits; now, therefore,






