WHEREAS, the policy requires the affirmative action by the Council for acceptance of an anonymously donated gift for a restricted use; and

WHEREAS, through a letter, the Director of Enterprise Services has submitted a request to the Council that was approved by the Managing Director for acceptance of a gift valued at \$3,637.00 for the Honolulu Zoo; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the anonymously donated gift valued at \$3,637.00; and
