Your Committee on Public Health, Safety and Welfare, which considered Resolution 16-243 entitled:

“RESOLUTION RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM THE MINE SAFETY APPLIANCES TO PROVIDE RESCUE EQUIPMENT TO HONOLULU FIRE DEPARTMENT PERSONNEL FOR CONFINED SPACE RESPONSES,”

Your Committee finds that the acceptance of this gift conforms with the applicable provisions of Resolution 05-349, CD1, FD1, and that this gift will benefit the people of the City and County of Honolulu.
