### RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM GENERATIONS MAGAZINE

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution No. 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter to the Council, approved by the Managing Director, the Director of Parks and Recreation has submitted a request for acceptance of a gift of cash in the amount of \$2,000.00 (Two Thousand and No/100 Dollars) that will be used to assist with the production and logistics of the event, prize awards, contest ribbons, parking, and refreshments for participating seniors and an in-kind gift valued at \$2,000.00 (Two Thousand and No/100 Dollars) for publicity from Generations Magazine for the 2016 Mayor's Craft and Country Fair to be held on Saturday, November 19, 2016, at the Neal S. Blaisdell Center Exhibition Hall; and

WHEREAS, the description and value of the gift is set forth in the Declaration of Gift (Exhibit A), attached hereto and incorporated herein; now, therefore,


