Your Committee on Budget, which considered Bill 55 (2016) entitled:

"A BILL FOR AN ORDINANCE AMENDING ORDINANCE 16-25, RELATING TO  
PRIVATE TRANSPORTATION SERVICES AND DRIVERS,"

which passed first reading at the September 7, 2016 Council meeting, reports as follows:

The purpose of the Bill is to make amendments to Ordinance 16-25, relating to private transportation services and drivers.

The Director and Licensing Administrator from the Department of Customer Services (CSD) testified in support of the Bill since the Bill is intended to provide more time to address rule changes with a reasonable implementation phase and enforcement phase to follow. The Director also noted that the Department is in the process of revising rules and staff positions.

Your Committee received testimony from two individuals in support, one individual in opposition, and one individual offering comments on the Bill.


