Mr. Chair:

Your Committee on Public Health, Safety and Welfare, which considered Resolution 16-229 entitled:

"RESOLUTION RELATING TO THE REAPPOINTMENT OF JERALD K. DOLAK TO SERVE ON THE CITIZENS ADVISORY COMMISSION ON CIVIL DEFENSE OF THE CITY AND COUNTY OF HONOLULU,"

introduced on August 24, 2016, reports as follows:

The purpose of the Resolution is to confirm the reappointment of Jerald K. Dolak to serve on the Citizens Advisory Commission on Civil Defense of the City and County of Honolulu. The Mayor has requested Council confirmation of the reappointment of Mr. Dolak through Mayor's Message No. 90 for a term which expires on March 31, 2021.

A public hearing on the appointment was held on October 5, 2016.

Mr. Dolak appeared before your Committee and expressed his willingness to continue serving on the Commission. He expressed an interest in finding a way for the Commission to expand their ability to address public and neighborhood board requests for presentations related to civil defense issues.

RESOLUTION

RELATING TO THE REAPPOINTMENT OF JERALD K. DOLAK TO SERVE ON THE CITIZENS ADVISORY COMMISSION ON CIVIL DEFENSE OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-104 of the Revised Charter of the City and County of Honolulu 1973 ("Charter"), as amended, establishes a Citizens Advisory Commission on Civil Defense ("Commission"), comprised of five members appointed by the Mayor and confirmed by the Council to five-year terms; and

WHEREAS, the Commission has the basic duties of advising the Mayor, the Council, and the Civil Defense Administrator on matters pertaining to civil defense, and promoting community understanding and interest in such matters; and

WHEREAS, by Mayor's Message No. 90 (2016), the Mayor has reappointed Jerald K. Dolak to the Citizens Advisory Commission on Civil Defense; and

WHEREAS, by Mayor's Message No. 100 (2016), the Mayor has submitted a revised nomination form from Jerald K. Dolak clarifying his ability to commit to the full term of his reappointment; and

WHEREAS, if confirmed by the Council, Jerald K. Dolak, whose initial term expired on March 31, 2016, will serve a term to expire on March 31, 2021; and

WHEREAS, Section 13-103, RCH, which applies to the Citizens Advisory Commission on Civil Defense, requires a member to be a registered voter of the City; and

WHEREAS, the Council has reviewed Jerald K. Dolak's qualifications and character and finds that he qualifies to serve on the Citizens Advisory Commission on Civil Defense and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the reappointment of Jerald K. Dolak to the Citizens Advisory Commission on Civil Defense for a term expiring on March 31, 2021; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Jerald K. Dolak for his willingness to be considered for public service and actively participate in city government; and
