Mr. Chair:

Your Committee on Budget, which considered the following:

“TAX COMPROMISE OF HAWAII CEDAR CHURCH — TMK 8-5-003-013,”

transmitted by Communication D-682, dated September 28, 2016, from the Department of Budget and Fiscal Services, reports as follows:

The purpose of Communication D-682 is to request Council approval of real property tax compromise to \$600 for FY 14-15, FY 15-16, and FY 16-17 which represents the real property taxes due on the property located at 85-596 I Waianae Valley Road, identified by tax map key 8-5-003-013. The property tax liability for this property is \$2,846.01 (FY 14-15), \$2,863.68 (FY 15-16), and \$2,895.03 (FY 16-17) not including any penalty and interest. The amount of tax to be compromised is \$2,246.01 (FY 14-15), \$2,263.68 (FY 15-16), and \$2,295.03 (FY 16-17), respectively.

The Deputy Director of Budget and Fiscal Services testified in support of the compromise noting that the church provided employment and job training to homeless persons, and that the Department was able to provide an exemption to the Church for nonprofit charitable purposes.

Your Committee received testimony from one individual in support of the Resolution.


