WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition), as amended ("RCH"), requires that all department heads and the Managing Director, nominated by the Mayor, be subject to the advice and consent of the City Council; and

WHEREAS, Section 6-301, RCH, establishes the Department of Community Services, to be headed by a Director of Community Services; and

WHEREAS, Section 6-302, RCH, sets forth the powers, duties and functions of the Director of Community Services; and

WHEREAS, Section 4-104.1, RCH, requires that each department head be a registered voter of the City and County of Honolulu; and

WHEREAS, via Mayor's Message 2, dated January 2, 2017, the Mayor has nominated Gary K. Nakata to serve as Director of Community Services; and

WHEREAS, after review of the nominee's qualifications, the City Council finds that Gary K. Nakata is qualified to serve as Director of Community Services and warrants confirmation; now, therefore,

BE IT RESOLVED by the City Council of the City and County of Honolulu that Gary K. Nakata be confirmed as the Director of Community Services of the City and County of Honolulu; and
