



**RESOLUTION**

WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition), as amended ("RCH") requires that all department heads and the Managing Director, nominated by the Mayor, to be subject to the advice and consent of the City Council; and

WHEREAS, Section 5-201, RCH, establishes the Department of the Corporation Counsel to be headed by a Corporation Counsel; and

WHEREAS, Section 5-202, RCH, requires the Corporation Counsel be an attorney licensed to practice and in good standing before the Supreme Court of the State of Hawaii and who shall have engaged in the practice of law for at least five years; and

WHEREAS, Section 5-203, RCH, sets forth the powers, duties and functions of the Corporation Counsel; and

WHEREAS, Section 4-104.1, RCH, requires that each department head be a registered voter of the City and County of Honolulu; and

WHEREAS, via Mayor's Message 2, dated January 2, 2017, the Mayor has nominated Donna Y.L. Leong to serve as Corporation Counsel; and

WHEREAS, after review of the nominee's qualifications, the City Council finds that Donna Y.L. Leong is qualified to serve as Corporation Counsel and warrants confirmation; now, therefore,

BE IT RESOLVED by the City Council of the City and County of Honolulu that Donna Y.L. Leong is confirmed as Corporation Counsel for the City and County of Honolulu; and


