WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition), as amended ("RCH"), requires that all department heads and the Managing Director, nominated by the Mayor, be subject to the advice and consent of the City Council; and

WHEREAS, Section 6-401, RCH, establishes the Department of Customer Services to be headed by a Director of Customer Services; and

WHEREAS, Section 6-402, RCH, sets forth the duties and functions of the Director of Customer Services; and

WHEREAS, Section 4-104.1, RCH, requires that each department head be a registered voter of the City and County of Honolulu; and

WHEREAS, via Mayor's Message 2, dated January 2, 2017, the Mayor has nominated Sherilyn T. Kajiwara to serve as Director of Customer Services; and

WHEREAS, after review of the nominee's qualifications, the City Council finds that Sherilyn T. Kajiwara is qualified to serve as Director of Customer Services and warrants confirmation; now, therefore,

BE IT RESOLVED by the City Council of the City and County of Honolulu that Sherilyn T. Kajiwara is confirmed as the Director of Customer Services of the City and County of Honolulu; and


