## RESOLUTION

RELATING TO THE NOMINATION OF DR. CHRISTOPHER HAPPY, TO SERVE AS THE MEDICAL EXAMINER OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973, as amended ("RCH"), requires that all department heads and the Managing Director, nominated by the Mayor, be subject to the advice and consent of the City Council; and

WHEREAS, Section 6-1301, RCH, establishes the Department of the Medical Examiner to be headed by a Medical Examiner; and

WHEREAS, Section 6-1302, RCH, requires that the Medical Examiner shall be a pathologist and licensed physician, and shall possess such additional licenses and certifications as state law may from time to time prescribe as qualifications for the performance of autopsies; and

WHEREAS, Section 6-1303, RCH, sets forth the powers, duties and functions of the Medical Examiner; and

WHEREAS, Section 4-104.1 of the Charter requires that each department head be a registered voter of the City and County of Honolulu; and

WHEREAS, via Mayor's Message 2, dated January 2, 2017, the Mayor has nominated Dr. Christopher Happy to serve as the Medical Examiner of the City and County of Honolulu; and

WHEREAS, after review of the nominee's qualifications, the City Council finds that Dr. Christopher Happy is qualified to serve as the Medical Examiner and warrants confirmation; now, therefore,

BE IT RESOLVED by the City Council of the City and County of Honolulu that Dr. Christopher Happy is confirmed as the Medical Examiner of the City and County of Honolulu; and




