



RESOLUTION

RELATING TO THE NOMINATION OF MICHELE K. NEKOTA, TO SERVE AS THE DIRECTOR OF THE DEPARTMENT OF PARKS AND RECREATION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition), as amended ("RCH"), requires that all department heads and the Managing Director, nominated by the Mayor, be subject to the advice and consent of the City Council; and

WHEREAS, Section 6-1401, RCH, establishes the Department of Parks and Recreation, to be headed by a Director of Parks and Recreation; and

WHEREAS, Section 6-1402, RCH, requires that the Director have a minimum of five years of training and experience in a parks and recreation position or in related fields, at least three years of which shall have been in a responsible administrative capacity; and

WHEREAS, Section 6-1403, RCH, sets forth the powers, duties and functions of the Director of Parks and Recreation; and

WHEREAS, Section 4-104.1, RCH, requires that each department head be a registered voter of the City and County of Honolulu; and

WHEREAS, via Mayor's Message 2, dated January 2, 2017, the Mayor has nominated Michele K. Nekota to serve as Director of Parks and Recreation; and

WHEREAS, after review of the nominee's qualifications, the City Council finds that Michele K. Nekota is qualified to serve as Director of Parks and Recreation and warrants confirmation; now, therefore,

BE IT RESOLVED by the City Council of the City and County of Honolulu that Michele K. Nekota is confirmed as the Director of Parks and Recreation of the City and County of Honolulu; and
