Your Committee on Parks, Community and Customer Services, which considered Resolution 16-258 entitled:

"RESOLUTION URGING THE CITY ADMINISTRATION TO ALLOW THE HAWAII KAI SATELLITE CITY HALL TO CONTINUE TO OPERATE AT ITS CURRENT LOCATION AND UPDATE THE HONOLULU CITY COUNCIL WITH REGARD TO THE HAWAII KAI SATELLITE CITY HALL'S STATUS,"


