ACCEPTING A GIFT TO THE CITY AND COUNTY OF HONOLULU FROM THE ASSOCIATION OF SKATEBOARDERS IN HAWAII FOR THE SKATE PARK LOCATED WITHIN EWA BEACH COMMUNITY PARK.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu, as amended, provides the City Council with sole authority to accept gifts on behalf of the City and County of Honolulu ("City"); and

WHEREAS, the Council has established a gift policy for the executive branch by adopting Resolution 05-349, CD1, FD1, and has accepted gifts to the legislative branch consistent with this policy; and

WHEREAS, the Association of Skateboarders in Hawaii has offered a donation to the City consisting of two concrete skateboarding obstacles valued at \$37,000.00, to be installed at the skate park located within the Ewa Beach Community Park; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift, attached as Exhibit A, and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it hereby accepts the gift to the City from the Association of Skateboarders in Hawaii of two concrete skateboarding obstacles to be installed at the skate park located within Ewa Beach Community Park; and

BE IT FURTHER RESOLVED that no special treatment or consideration will be given the donor by the City as a result of the gift; and

BE IT FURTHER RESOLVED that the Council expresses its deep appreciation to the Association of Skateboarders in Hawaii for this generous gift to the City; and
