



**RESOLUTION**

RELATING TO THE APPOINTMENT OF FERNANDO J. FRONTERA TO SERVE ON THE BUILDING BOARD OF APPEALS OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 16-1.1(13), Revised Ordinances of Honolulu 1990 ("ROH"), establishes the Building Board of Appeals ("Board") consisting of nine members who are appointed by the Mayor and confirmed by the Council to five-year terms; and

WHEREAS, Section 16-1.1(13), ROH, provides that the Board has the duties of hearing and determining the following:

- (1) Appeals of decisions regarding the administration of the Building Code, Electrical Code, Plumbing Code, Housing Code, Fire Code, Building Energy Efficiency Standards, and building permit ordinance;
- (2) Petitions for variances from the Building Code, Electrical Code, Plumbing Code, Fire Code, and Building Energy Efficiency Standards;
- (3) Appeals of decisions regarding the administrative enforcement of the litter control ordinance; and
- (4) Appeals concerning the summary removal of unlawful signs from street rights-of-way and public malls;

and

WHEREAS, by Mayor's letter, dated February 8, 2017 the Mayor has appointed Mr. Fernando J. Frontera to the Board; and

WHEREAS, if confirmed by the Council, Mr. Frontera will replace Dr. Glenn H. Miyasato, whose term expired on June 30, 2016, and will serve for a term to expire on December 31, 2019; and

WHEREAS, Section 16-1.1(13), ROH, establishes a general qualification requiring each member of the Board to be "qualified by experience and training to pass upon matters pertaining to building construction and fire safety"; and

WHEREAS, Section 13-103(a), Revised Charter of the City and County of Honolulu 1973, as amended, which applies to the Board, requires a member to be a registered voter of the City; and



BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the Mayor, the Chair of the Building Board of Appeals, and Mr. Fernando J. Frontera.
