**A BILL FOR AN ORDINANCE**

---

RELATING TO MOTOR VEHICLE REGISTRATION.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. The purpose of this ordinance is to address the registration of new and used motor vehicles.

SECTION 2. The title of Chapter 41, Article 18, Revised Ordinances of Honolulu 1990, is amended to read as follows:

**"Article 18. [Fees for] Motor Vehicle Registration"**

SECTION 3. Chapter 41, Article 18, Revised Ordinances of Honolulu 1990 ("Fees for Motor Vehicle Registration"), is amended by adding a new Section 41-18.7 to read as follows:

**"Sec. 41-18.7 Registration of new and used motor vehicles.**

The director of budget and fiscal services, in coordination with the director of customer services, shall enter into contracts with car dealerships and motor vehicle rental companies for the registration of new and used motor vehicles consistent with any statute, ordinance, or provision of any applicable collective bargaining agreement. The director may adopt rules pursuant to chapter 91 as may be necessary for the application, bonding, and procedural requirements of the contractor."

SECTION 4. Ordinance material to be repealed is bracketed. New material is underscored. When revising, compiling or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the revisor of ordinances need not include the brackets, the bracketed material or the underscoring.






