



RESOLUTION

RELATING TO TRANSFER OF FUNDS.

WHEREAS, Section 2-17.2(c)(1), Revised Ordinances of Honolulu 1990, as amended, requires that the City Council approve by resolution any transfer of funds between activities whenever the cumulative amount of transfers from or to an activity totals in excess of \$100,000 or 10 percent of the amount appropriated for that activity; and

WHEREAS, Section 2-17.2(c), Revised Ordinances of Honolulu 1990, as amended, requires the City Council's approval by resolution any transfer of funds between characters of expenditure within the same activity whenever the cumulative amount of transfers from or to a character of expenditure exceeds the lesser of \$100,000 or 10 percent of the appropriation for either the originating or receiving character of expenditure in the executive operating budget ordinance provided that the 10 percent portion exceeds \$10,000; and

WHEREAS, a transfer not to exceed \$45,000 between characters of expenditure is required to meet the equipment expense needs of the Special Field Operations Bureau; now, therefore,

BE IT RESOLVED by the City Council of the City and County of Honolulu that \$45,000 in General Fund monies be transferred between the following characters of expenditure; and


