TO REQUEST ADDITIONAL FUNDS FOR CONTRACT NO. SC-COR-1700021 TO CONTINUE THE SERVICES OF KOBAYASHI, SUGITA, & GODA, LLP AS SPECIAL COUNSEL FOR THE CITY AND COUNTY OF HONOLULU TO REPRESENT DEFENDANT LETHA A.S. DECAIRES IN A LEGAL ACTION ENTITLED, KEALOHA, ET AL. V. TOTTO, ET AL., CIVIL NO. 16-1-1166-6 GWBC.

WHEREAS, by way of Resolution No.16-223, the Council of the City and County of Honolulu ("Council") approved the retention of the law firm of Kobayashi, Sugita, & Goda, LLP ("Special Counsel"), to represent and defend the interests of Letha A.S. DeCaires, named as a Defendant in the civil action entitled Kealoha, et al. v. Tutto, et al., Civil No.16-1-1166-6 GWBC; and

WHEREAS, by way of Resolution No. 16-223, Council authorized an allotment to Special Counsel in the maximum of \$100,000.00 for legal fees and costs in the defense of the above-referenced Defendants in the above-referenced lawsuit; and

WHEREAS, to date, Special Counsel has billed the City a total \$41,313.00, and has indicated that additional funds are necessary; and

WHEREAS, Special Counsel has requested the approval of additional funds to cover anticipated legal fees and costs in defense of Defendant Letha A.S. Decaires in the lawsuit; and

WHEREAS, based on the above, it appears that an increase in the amount of fees is warranted and Corporation Counsel has recommended the allotment of additional sums; now, therefore,


BE IT RESOLVED by the Council of the City and County of Honolulu, pursuant to the mandate of Sections 5-203 and 5-204.3 of the Revised Charter of the City and County of Honolulu 1973, as amended, that an additional \$100,000.00 be allotted for payment of the law firm of Kobayashi, Sugita, & Goda, LLP, in accordance with all the terms and conditions set forth in Resolution No. 16-223, bringing the total amount authorized by Council resolution to \$200,000.00; and
