



RESOLUTION

ACCEPTING A GIFT TO THE CITY FOR TRAVEL-RELATED EXPENSES TO VISIT INCHEON, REPUBLIC OF KOREA, FROM MAY 14 TO MAY 19, 2017.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition), as amended, provides the City Council ("Council") with authority to accept gifts to the City; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy provides for the acceptance of a gift by affirmative action by the Council; and

WHEREAS, through a letter dated March 23, 2017, the Incheon Metropolitan Council has invited a delegation from the Honolulu City Council to visit Incheon, Republic of Korea, from May 14 to May 19, 2017; and

WHEREAS, Incheon Metropolitan City has offered to pay for costs of the delegation's trip, including room and board for two delegation members in Incheon valued at \$4,000; and

WHEREAS, this visit provides an opportunity for the City and County of Honolulu to maintain its Sister City relationship with the government, people, and businesses in Incheon, Republic of Korea, which became Honolulu's sister city via adoption of Resolution 03-210; and

WHEREAS, the Honorable Jegal Won Young, Chair of the Incheon Metropolitan Council has invited Council Chair Emeritus Ernest Martin and Councilmember Ann Kobayashi of the Honolulu City Council to conduct this visit; and

WHEREAS, through a Declaration of Gift dated April 11, 2017, attached hereto as Exhibit A and incorporated herein, Incheon Metropolitan City has submitted a request to the Council for the acceptance of a gift to the City valued at \$4,000 for travel-related expenses for two delegates to visit Incheon, Republic of Korea, from May 14 to May 19, 2017; and

WHEREAS, the description and value of the gift are set forth in Exhibit A; now, therefore,




