



RESOLUTION

RELATING TO THE APPOINTMENT OF CHERYL M. PALESH TO SERVE ON THE BUILDING BOARD OF APPEALS OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 16-1.1(13), Revised Ordinances of Honolulu 1990 ("ROH"), establishes the Building Board of Appeals consisting of nine members who are appointed by the Mayor and confirmed by the Council to staggered five-year terms; and

WHEREAS, Section 16-1.1(13), ROH, provides that the Board has the duties of hearing and determining the following:

- (1) Appeals of decisions regarding the administration of the Building Code, Electrical Code, Plumbing Code, Housing Code, Fire Code, Building Energy Efficiency Standards, and building permit ordinance;
- (2) Petitions for variances from the Building Code, Electrical Code, Plumbing Code, Fire Code, and Building Energy Efficiency Standards;
- (3) Appeals of decisions regarding the administrative enforcement of the litter control ordinance; and
- (4) Appeals concerning the summary removal of unlawful signs from street rights-of-way and public malls;

and

WHEREAS, by Mayor's letter, dated April 26, 2017 the Mayor has reappointed Ms. Cheryl M. Palesh to the Building Board of Appeals; and

WHEREAS, if confirmed by the Council, Ms. Palesh, whose initial term expired on December 31, 2016, will serve for a second term to expire on December 31, 2021; and

WHEREAS, Section 16-1.1(13), ROH, establishes a general qualification requiring each member of the Building Board of Appeals to be "qualified by experience and training to pass upon matters pertaining to building construction and fire safety"; and

WHEREAS, Section 13-103(a), Revised Charter of the City and County of Honolulu 1973, as amended, which applies to the Building Board of Appeals, requires a member to be a registered voter of the City; and


