



RESOLUTION

RELATING TO THE APPOINTMENT OF WILLIAM H. HONG TO SERVE ON THE FIRE COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-1005, Revised Charter of the City and County of Honolulu 1973, as amended ("RCH"), establishes a Fire Commission consisting of seven members appointed by the Mayor and approved by the Council; and

WHEREAS, Section 6-1006, RCH, outlines the major duties of the Fire Commission, as follows:

- (1) Adopt rules necessary for the conduct of its business and review rules for the administration of the Honolulu Fire Department (HFD);
- (2) Review the annual budget as prepared by the Fire Chief and make recommendations thereon to the Mayor and the Council;
- (3) Review HFD's operations, as deemed necessary, for the purpose of recommending improvements to the Fire Chief;
- (4) Evaluate at least annually the performance of the Fire Chief and submit a report to the Mayor and Council;
- (5) Review personnel actions within HFD for conformance with the policies under Section 6-1002 of the RCH;
- (6) Hear complaints of citizens concerning HFD or its personnel and, if deemed necessary, make recommendations to the Fire Chief on appropriate corrective actions;
- (7) Submit an annual report to the Mayor and the Council on its activities;

and

WHEREAS, by Mayor's letter, dated April 26, 2017, the Mayor has appointed Mr. William H. Hong to the Fire Commission; and

WHEREAS, if confirmed by the Council, Mr. Hong will serve for an initial term to expire on December 31, 2021; and



RESOLUTION

WHEREAS, Section 13-103, RCH, which applies to the Fire Commission, includes a general qualification requiring a member to be a registered voter of the City; and

WHEREAS, the Council has reviewed the qualifications and character of Mr. Hong and finds that he qualifies to serve on the Fire Commission and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body confirms the appointment of Mr. William H. Hong to the Fire Commission for a term expiring December 31, 2021; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Hong for his willingness to be considered for public service and actively participate in City government; and

BE IT FINALLY RESOLVED that copies of this Resolution be transmitted to the Mayor, the Fire Chief, the Chair of the Fire Commission, and Mr. William H. Hong.


