



**A BILL FOR AN ORDINANCE**

RELATING TO FEES FOR USE OF MUNICIPAL GOLF COURSES.

BE IT ORDAINED by the People of the City and County of Honolulu:

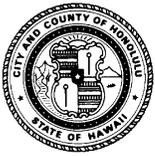
SECTION 1. Purpose and Intent. The purpose of this ordinance is to amend the fees for the use of the City's golf courses.

SECTION 2. Section 10-4.2 Revised Ordinances of Honolulu 1990, is amended to read as follows:

**"Sec. 10-4.2 Green fees.**

The following green fees shall be assessed per round of golf for use of the golf course facilities operated by the city:

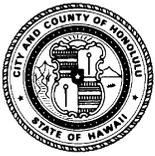
