



RESOLUTION

CONFIRMING THE APPOINTMENT OF CHERYL D. SOON TO SERVE AS CHAIR OF THE RATE COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-1704 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition), as amended, establishes a Rate Commission consisting of seven members who, after the terms of the initial appointees to the Rate Commission, shall thereafter serve five-year staggered terms; and

WHEREAS, three members of the Rate Commission are appointed by the Council, three members are appointed by the Mayor without Council confirmation, and one member, who will serve as the Rate Commission Chair, is appointed by the Mayor and confirmed by the Council; and

WHEREAS, the Rate Commission has a range of duties, including: adopting rules for the conduct of its business; reviewing, at least annually, the fares, fees, rates, tolls and other charges for the use of any and all modes of the multimodal municipal transportation system, and recommending adjustments thereto, subject to Council approval; and submitting an annual report to the Director of Transportation Services, Mayor, and Council; and

WHEREAS, by Mayor's Message MM-83 (2017), the Mayor informed the Council of his appointment of Cheryl D. Soon to the position of Chair of the Rate Commission, with a term to expire on June 30, 2022; and

WHEREAS, the Council has reviewed the qualifications and character of the Mayor's appointee and finds Ms. Soon to be deserving of appointment; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the appointment of Cheryl D. Soon to serve as Chair of the Rate Commission for a term expiring on June 30, 2022; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Cheryl D. Soon for her willingness to be considered for public service and actively participate in City government; and


