



RESOLUTION

RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM NAGOYA TOYOPET INC. TO ASSIST WITH REPLACEMENT COSTS OF THE WAIKIKI HISTORIC TRAIL MARKER "ALA MOANA PARK."

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (2000 Edition), as amended, provides the City Council with authority to accept gifts to the City; and

WHEREAS, Resolution No. 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of the gifts donated to the City and provides for acceptance of the gifts by affirmative action by the Council; and

WHEREAS, through Mayor's Message No. 57 (2017), approved by the Managing Director, the Executive Director of the Mayor's Office of Culture and the Arts, has submitted a request to the Council for acceptance of a gift to the City in the amount of \$3,000 to be used to assist with the replacement costs of the "Ala Moana Park" Waikiki Historic Trail marker sign; and

WHEREAS, Mr. Nanao Oguri, Chief Executive Officer of Nagoya Toyopet Inc., Japan's largest independent Toyota car dealership, founded in 1956, visits Honolulu regularly, as do employees of the company, and he desires to contribute monetary gifts to the City; and

WHEREAS, Nagoya Toyopet Inc. has made annual monetary gifts to the City for several years; and

WHEREAS, this monetary gift will supplement the replacement costs of the "Ala Moana Park" (1999.08.09) Waikiki Historic Trail marker sign by Charles Palumbo installed in 1999, which was destroyed on November 15, 2007, as reported in the Honolulu Police Department Motor Vehicle Accident Report Number 07-455413, located in Ala Moana Regional Park near the intersection of Ala Moana Boulevard and Atkinson Drive; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accept the gift of cash in the amount of \$3,000 from Nagoya Toyopet Inc. that is more fully described in Mayor's Message No. 57 (2017) and the Declaration of Gift attached as Exhibit A; and




