



## RESOLUTION

---

RELATING TO THE REAPPOINTMENT OF CLAIRE J. TAMAMOTO TO SERVE ON THE NEIGHBORHOOD COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 14-102, Revised Charter of the City and County of Honolulu 1973, as amended ("RCH"), establishes the Neighborhood Commission ("Commission"); and

WHEREAS, pursuant to Section 14-103, RCH, the duties of the Commission are to develop the neighborhood plan, evaluate the effectiveness of the neighborhood plan and neighborhood boards, and assist in the formation and operation of neighborhood boards upon their request; and

WHEREAS, the Commission consists of nine members appointed to five-year terms as follows: four are appointed by the Council Presiding Officer, with the approval of the Council; four are appointed by the Mayor without necessity of Council confirmation; and one is appointed by the Mayor and confirmed by the Council; and

WHEREAS, Section 14-102, RCH, provides that of the four members appointed by the Council Presiding Officer, at least two shall have served on a neighborhood board for at least one term; and

WHEREAS, the Council Presiding Officer has reappointed Claire J. Tamamoto to the Neighborhood Commission to serve a term expiring on June 29, 2022; and

WHEREAS, Section 13-103, RCH, requires members of the Commission to be registered voters; and

WHEREAS, the Council has reviewed the qualifications and character of Claire J. Tamamoto and finds that she qualifies to serve on the Commission and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Claire J. Tamamoto be approved as one of the Council Presiding Officer's appointments to the Neighborhood Commission for a term expiring on June 29, 2022; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Claire J. Tamamoto for her willingness to be considered for public service and actively participate in City government; and
