



RESOLUTION

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu; and

WHEREAS, Resolution 05-349, C.D.1, F.D.1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Chief of Police of the Honolulu Police Department (hereinafter HPD) has submitted a request to the Council that was approved by the Managing Director for the acceptance of a gift valued at \$9,500 from The Deputies that will be used toward awards, pins, equipment, travel expenses, and scholarships for the HPD's Law Enforcement Explorer Program; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift (Exhibit A) and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift valued at \$9,500 from The Deputies that is more fully described in the above-mentioned letter from the Chief of Police of the HPD; and

BE IT FURTHER RESOLVED that the Council expresses its appreciation to The Deputies for this gift to the City; and


