RESOLUTION

ACCEPTING A GIFT TO THE CITY FROM MRS. SHEILA WATUMULL FOR THE HONOLULU ZOO.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu provides for the acceptance of gifts to the City and County of Honolulu ("City") by the City Council ("Council"); and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a Council policy on the acceptance of gifts donated to the City; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter, the Director of Enterprise Services submitted a request to the Council that was approved by the Managing Director for the acceptance of a gift to the City from Mrs. Sheila Watumull of \$5,000 for an elephant bull drinker at the Honolulu Zoo; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift (Exhibit A) attached hereto and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift of \$5,000.00 from Mrs. Sheila Watumull that is more fully described in the above-mentioned letter from the Director of Enterprise Services and the Declaration of Gift attached as Exhibit A; and
