MINUTES OF OCTOBER 25, 2017 REGULAR MEETING

1. **BILL 86 (2017) – DISPOSAL OF WEEDS, GARBAGE, TRASH, AND WASTE.** Addressing the disposal of weeds, garbage, trash, and waste from vacant lots. (Bill passed first reading on 10/11/17; Committee deferred action on 10/25/17)

PROPOSED CD1 TO BILL 86 (2017) (Submitted by Councilmember Ozawa) – The CD1 (OCS2017-1168/11/7/2017 11:16 AM) makes the following amendments:

- A. Amends the proposed amended definition of "Property" to provide that privately owned vacant lots of 15,000 square feet or less are subject to the requirements of ROH Chapter 41, Article 10. (The threshold in the current law is 7,500 square feet or less.)
 - B. Makes miscellaneous technical and nonsubstantive amendments.
2. **BILL 71 (2017) – ENVIRONMENTAL HEALTH.** Addressing environmental health concerns related to the use of certain types of disposable food containers. (Bill passed first reading on 9/6/17)
 3. **BILL 73 (2017) – LITTER REDUCTION.** Reducing litter in City parks. (Bill passed first reading on 8/9/17; Committee deferred action on 8/23/17)

PROPOSED CD1 TO BILL 73 (2017) (Submitted by Councilmember Fukunaga) – The CD1 (OCS2017-0865/8/17/2017 2:40 pm) makes the following amendments:

- A. Amends SECTION 3 to remove the underscoring of the amendatory language.
- B. Makes other miscellaneous technical and non-substantive amendments.
