RESOLUTION

RELATING TO THE ACCEPTANCE OF A GIFT TO THE CITY FROM STATE FARM INSURANCE TO ACQUIRE AN ACCELERANT DETECTION CANINE AND PROVIDE TRAINING.

WHEREAS, the Revised Charter of the City and County of Honolulu 1973 (2017 Edition), Section 13-113, provides for the acceptance of gifts to the City and County of Honolulu ("City") by the City Council ("Council"); and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council on the acceptance of gifts donated to City executive agencies; and

WHEREAS, the policy provides for the acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated November 9, 2017 (Dept. Com. 779), and approved by the Managing Director, the Fire Chief of the Honolulu Fire Department ("HFD") has submitted a request to the Council for acceptance of a gift to the City from State Farm Insurance valued at \$25,000 to acquire an accelerant detection canine and provide training for HFD personnel; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift of \$25,000 from State Farm Insurance that is more fully described in the above-mentioned letter and the Declaration of Gift attached as Exhibit A; and
