ACCEPTING A GIFT TO THE CITY FROM THE CHENGDU FOREIGN AND OVERSEAS CHINESE AFFAIRS OFFICE.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (2017 Edition) provides the City Council ("Council") with the authority to accept gifts to the City; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy provides for the acceptance of the gift by affirmative action by the Council; and

WHEREAS, the Chengdu Foreign and Overseas Chinese Affairs Office has invited a representative from the City and County of Honolulu ("City") to attend the 2018 China (Chengdu) Global Innovation and Entrepreneurship Fair ("GIEF 2018"), in Chengdu, China from May 18-20, 2018; and

WHEREAS, in association with this invitation, the Office of the Mayor has been offered an expenses-paid trip for one Honolulu representative to attend the GIEF 2018 that includes airfare, accommodations, meals, and local transportation valued at \$2,779; and

WHEREAS, the Office of the Mayor has asked Councilmember Joey Manahan to attend the GIEF 2018 as the representative from Honolulu, and Councilmember Manahan has accepted, as reflected in the description of the gift section in a Declaration of Gift form provided by the Chengdu Foreign and Overseas Chinese Affairs Office; and

WHEREAS, the full description, value breakdown, and purpose of the gift are set forth in the Declaration of Gift form attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift valued at \$2,779 from the Chengdu Foreign and Overseas Chinese Affairs Office that is documented in Exhibit A; and


