



A BILL FOR AN ORDINANCE

TO AMEND CHAPTER 10, ARTICLE 4, REVISED ORDINANCES OF HONOLULU, 1990, AS AMENDED RELATING TO FEES FOR USE OF MUNICIPAL GOLF COURSES.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose and Intent. The purpose of this ordinance is to increase golf fees. The revenues generated by the golf fee and golf cart rental fee increases will be used to offset the cost of the municipal golf course operations.

SECTION 2. Section 10-4.2, Revised Ordinances of Honolulu 1990, is amended to read as follows:

"Sec. 10-4.2 Green fees.

The following green fees shall be assessed per round of golf for use of the golf course facilities operated by the city:


