



A BILL FOR AN ORDINANCE

TO AMEND CHAPTER 41, ARTICLE 25, REVISED ORDINANCES OF HONOLULU 1990, AS AMENDED, RELATING TO DAMAGE TO PUBLIC PROPERTY.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this ordinance is to amend Article 25 ("Damage to Public Property") of ROH Chapter 41 regarding damage to public property and to update the definition of the director of finance.

SECTION 2. Section 41-25.1, Revised Ordinances of Honolulu 1990 ("Definitions"), is amended by amending the definition of "director" to read as follows:

""Director" means the director of [~~finance.~~] budget and fiscal services."

SECTION 3. Section 41-25.3, Revised Ordinances of Honolulu 1990, as amended, is amended to read as follows:

"Sec. 41-25.3 Cost of repairs or replacement.

- (a) Any person who is responsible for damage to public property constituting a public nuisance, including damage [~~which~~] that causes the partial or complete closure or other loss of use or value, or loss of public property, shall be responsible for repairing or otherwise remedying such damage, including but not limited to payment of costs [~~incurred by the city in~~] of repairing, cleaning, or replacing the damaged property.
- (b) [~~The~~] issuance of the bill for the costs [~~incurred~~] shall be [~~issued~~] authorized by the [~~finance department~~] director and shall contain the amount to be charged by the city.
- (c) The costs billed shall be the actual or estimated costs [~~plus any administrative expenses~~] associated with the repair, cleaning, or replacement of the damaged property plus any administrative expenses."


