



RESOLUTION

ACCEPTING A GIFT TO THE CITY FROM THE DEPUTIES FOR THE HONOLULU POLICE DEPARTMENT'S LAW ENFORCEMENT EXPLORER PROGRAM.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973, as amended, provides the City Council ("Council") with the authority to accept gifts to the City; and

WHEREAS, Resolution 05-349, C.D.1, F.D.1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated August 10, 2018, approved by the Managing Director, the Chief of Police of the Honolulu Police Department (hereinafter HPD) has submitted a request to the Council for acceptance of a gift valued at \$9,500 from The Deputies that will be used towards awards, pins, equipment, and scholarships for the the HPD's Law Enforcement Explorer Program; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift valued at \$9,500 from The Deputies that is more fully described in the above-mentioned letter dated August 10, 2018, and the Declaration of Gift attached as Exhibit A; and
