WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu (City) provides for the acceptance of gifts to the City by the Council of the City and County of Honolulu (Council); and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the acceptance of gifts donated to City executive agencies; and

WHEREAS, the policy provides for acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated October 26, 2018, approved by the Managing Director, the Fire Chief of the HFD submitted a request to the Council for acceptance of a gift to the City from Hawaii Specialty Vehicles valued at \$1,000 to provide refreshments at an HFD apparatus blessing ceremony; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift statement (Exhibit A) and attached hereto; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body accepts the gift valued at \$1,000 from Hawaii Specialty Vehicles that is more fully described in the abovementioned letter dated October 26, 2018, and the Declaration of Gift attached as Exhibit A; and


