Mr. Chair:

Your Committee on Public Safety, to which was referred Resolution 04-20, entitled:

“RESOLUTION AUTHORIZING THE CHIEF OF POLICE OF THE CITY AND COUNTY OF HONOLULU TO ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE MARINE CORPS BASE HAWAII AND THE HONOLULU POLICE DEPARTMENT REGARDING THE USE OF EACH OTHER’S FACILITIES AND TRAINING,”

transmitted by Communication D-34, from the Chief of Police, Honolulu Police Department (HPD), dated January 2, 2004, and introduced on January 22, 2004, reports as follows:

The purpose of this Resolution is to authorize the Chief of Police to enter into a Memorandum of Agreement with the Marine Corps Base Hawaii to make available to each other their training, live fire ranges, training areas, and facilities to conduct sustainment training. In particular, this MOU will permit HPD's specialized services division and other HPD personnel to conduct training sessions at Marine Corp Base Hawaii facilities on a space-available basis.

Your Committee notes that upon approval, this MOU will remain in effect until terminated by mutual agreement, or 30-days following the receipt of written notice of termination by either party.
