MINUTES OF THE MARCH 28, 2019 COMMITTEE ON PUBLIC SAFETY AND WELFARE MEETING.

1. **RESOLUTION 19-58 – REAPPOINTMENT OF GERARD G. GIBSON.** Confirming the reappointment of Mr. Gerard C. Gibson to serve on the Police Commission of the City and County of Honolulu, for a term to expire on December 31, 2023. (Transmitted by Communication MM-17) (Public hearing held on 4/17/19)
2. **RESOLUTION 19-77 – APPOINTMENT OF RICHARD M. PARRY.** Confirming the appointment of Richard M. Parry to serve on the Police Commission of the City and County of Honolulu, for a term to expire on December 31, 2022. (Transmitted by Communication MM-25) (Public hearing held on 4/17/19)
3. **RESOLUTION 18-298 – HONOLULU FIRE DEPARTMENT'S FIRE RECRUIT TRAINING AND TESTING PROGRAM.** Urging the Fire Commission of the City and County of Honolulu to immediately review the Honolulu Fire Department's existing operations related to its Fire Fighter Recruit Training and Testing Programs, and thereafter make recommendations to the Fire Chief, as appropriate. (Resolution recommitted back to Committee on 4/17/19)

CD1 TO RESOLUTION 18-298 (Submitted by Councilmember Formby) – The CD1 (OCS2019-0219/3/5/2019 5:11 PM) was approved by the Committee on its 3/28/19 meeting and makes the following amendments:

- A. Adds a new third "WHEREAS" clause quoting from Charter Section 6-1002 relating to the HFD's recruitment policies.
- B. Amends the eighth "WHEREAS" clause to read as follows:  
  
"WHEREAS, those FFRs who failed the initial skills test were [forced] required to take a [hastily scheduled] retest shortly after the initial skills test, without information from their Recruit Training Officer explaining the actions required to correct the deficiencies, and without any explanation provided to justify a same-day retest; and"

- C. Amends the tenth "WHEREAS" clause to read as follows:

"WHEREAS, these decisions pertaining to the immediate retest and dismissal of those FFRs [seem suspect and do) may not [appear to] be in accordance with NREMT guidelines and HFD's FFR Training Manual; and"

- D. Amends the eleventh "WHEREAS" clause to read as follows:

"WHEREAS, it is imperative that investigative action and corrective action, as appropriate, be taken immediately by the Fire Commission to address this issue, as the dismissed FFRs do not appear to have received fair treatment in keeping with the highest standards of professional conduct by the HFD; and"

- E. Amends the second "FURTHER RESOLVED" clause to read as follows:

"BE IT FURTHER RESOLVED that the Fire Commission is urged to encourage the Honolulu Fire Department to adopt and adhere to the National Registry of Emergency Medical Technicians Retest Policy, as appropriate; and"

- F. Deletes the third "FURTHER RESOLVED" clause.

In sections B, C, D and E above, new resolution language is underscored and resolution language being deleted is bracketed.

4. **RESOLUTION 19-95 – MEDICATION-ASSISTED TREATMENT PROGRAMS.**  
Urging the city administration to include medication-assisted treatment programs as part of its effort to address homelessness.
