Your Committee on Budget, to which was referred Resolution 20-55 entitled:

"RESOLUTION APPROVING AN AMENDMENT TO THE CITY AND COUNTY OF HONOLULU'S TWENTY-FIFTH (25th) YEAR ACTION PLAN FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS (HOME), HOUSING TRUST FUND (HTF), EMERGENCY SOLUTIONS GRANTS (ESG) AND HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA) PROGRAM FUNDS, AND AUTHORIZING ITS SUBMITTAL TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD),"

transmitted by Departmental Communication 116 (2020), dated February 14, 2020 from the Department of Community Services (DCS), and introduced on February 20, 2020, reports as follows:

The purpose of the resolution is to approve an amendment to the City's 25th Year Action Plan ("Action Plan") for CDGB, HOME, HTF, ESG, and HOPWA program funds. The amendment would reprogram \$51,136.00 in City matching funds for ESG from ALEA Bridge, a subrecipient, to the DCS to support program administration costs. If approved, the resolution further authorizes the Mayor or the Mayor's designee to execute and submit the amended Action Plan to HUD for their approval.

The Director of Community Services provided your Committee with a brief summary of the resolution and requested the Council's approval.
