**Kind of business:** The applicant proposed to open and operate a retail outlet that will accommodate their bridal and wedding salon with liquor; for off premise consumption. The retail sales will be available only to customers of the applicant's wedding operation; will not open to the public.

**Hours of Operation:** 09:30 A.M – 6:00 PM / Daily  
There will be approximately 75 employees to include 3 managers.

**Lease:** Effective as of February 16, 2018, by and between Best Hospitality LLC (Landlord), and Best Bridal Hawaii Inc. (Tenant).

**Term:** According to the actual lease agreement, it was terminated December 31, 2019, extended ninety (90) days thereafter to March 31, 2019.

According to the "Extension Amendment", the lease shall automatically extended in one (1) year increments (with each increment being considered part of the Extended Term), upon the same terms and conditions as the prior year, except (a) monthly Rent, and (b) Landlord may reasonably increase the required insurance.
