



RESOLUTION

AUTHORIZING THE CHIEF OF POLICE AND THE CITY AND COUNTY OF HONOLULU TO APPLY FOR AND, IF APPROVED, ACCEPT FUNDS FROM THE CRIME PREVENTION AND JUSTICE ASSISTANCE DIVISION, DEPARTMENT OF THE ATTORNEY GENERAL, STATE OF HAWAII, TO IMPLEMENT THE COMMUNITY ORIENTED POLICING SERVICES (COPS) METHAMPHETAMINE GRANT

WHEREAS, Chapter 1, Article 8, Revised Ordinances of Honolulu 1990, requires that when carrying out the provisions of any intergovernmental agreement, all applications and/or amendments thereof, statistical data programs, reports or other official communications which support the application and which are required to be provided by the City and County of Honolulu or its components departments to any other governmental or quasi-governmental agency shall first be presented to the City Council for its review and approval prior to its transmittal; and

WHEREAS, the Honolulu Police Department (hereinafter the HPD) and the Crime Prevention and Justice Assistance Division, Department of the Attorney General (hereinafter the CPJAD) have cooperated in the past toward the common goal of law enforcement in the State of Hawaii, and

WHEREAS, full cooperation by the HPD has not always been possible because of limited resources and increasing demands upon the HPD as a law enforcement agency; and

WHEREAS, the CPJAD is prepared to make available to the HPD funds to enhance the efforts of the police to address the rapidly growing methamphetamine problem in rural Oahu and increase public safety; and

WHEREAS, the HPD now wishes to apply for and, if approved, accept funds from a grant from the CPJAD; and

WHEREAS, a copy of this application is attached hereto as Exhibit A and by reference made a part of this resolution; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu, State of Hawaii, that the Chief of Police or duly appointed representative is authorized to apply for and accept funds from the CPJAD; and

PART II. DESCRIPTION OF PROJECT

COPS METHAMPHETAMINE GRANT

This contract between the Department of the Attorney General and the Honolulu Police Department implements the Community Oriented Policing Services (COPS) Methamphetamine Grant (a multi-county effort involving the Honolulu Police Department, the Maui Police Department, and the Kauai Police Department) in the City and County of Honolulu. Each county formulated its strategy to reduce the use of crystal methamphetamine and other drugs.

SUMMARY OF THE HONOLULU POLICE DEPARTMENT PROJECT

In rural Oahu, the Honolulu Police Department (HPD) will work with neighborhood boards or communities to identify public parks where drugs are used and sold. Enforcement will be undertaken to improve public safety by ridding the parks of drug activity. Training for neighborhood security watches/citizen patrols will be undertaken, and the citizens will be equipped to conduct the patrols as well as assess the environmental changes that could be made. The HPD will send teams of community participants and police officers to attend a Community Action Seminar (CAS). The CAS assists teams to identify problems, establish goals, objectives, outcomes, and develop implementation plans. A small pool of funds may be available to help community teams implement their plans.

Performance indicators will include:

- Number of neighborhood board/community meetings
- Number attending each meeting
- Description of selected parks
- Number and composition of those attending the CAS
- Summary of action plan
- Summary of implemented action plans
- Assessment on the impact the program made on reducing drug use
(for example, the reduction of drug use by ___ percent before and after the program, reduction in number of complaints, etc.)
- Results of law enforcement activities (i.e., number of drug arrests)


