WHEREAS, the Council must decide on the Locally Preferred Alternative for a mass transit solution for Honolulu at the end of this year; and

WHEREAS, in order to make an informed decision on the Locally Preferred Alternative, it will be helpful for the Council to view existing mass transit rail lines in other jurisdictions; and

WHEREAS, Bombardier Transportation is offering to provide airfare and lodging for two Councilmembers to travel to and view mass transit lines in Vancouver, British Columbia and Las Vegas, Nevada; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift, attached as Exhibit A, and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it accepts the gift of airfare and lodging for two Councilmembers to view and tour mass transit rail lines in Vancouver, British Columbia and Las Vegas, Nevada, valued at \$2,900; and


