



A BILL FOR AN ORDINANCE

REPEALING THE REQUIREMENT THAT FOREIGN PERSONS REPORT THE INTERESTS THEY OWN OR ACQUIRE IN HONOLULU REAL PROPERTY.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. The purpose of this ordinance is to repeal the requirement that Honolulu real property interests owned or acquired by foreign persons be reported to the city.

SECTION 2. Article 14 of Chapter 8, Revised Ordinances of Honolulu 1990, as amended, ("Reporting of Honolulu Real Property Interests Owned or Acquired by Foreign Persons"), is repealed.


