## A BILL FOR AN ORDINANCE

A BILL FOR AN ORDINANCE TO AMEND CHAPTER 9, REVISED ORDINANCES OF HONOLULU 1990, AS AMENDED, RELATING TO COLLECTION AND DISPOSAL OF REFUSE.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose. The purpose of this ordinance is to increase the unit charge at disposal facilities.

SECTION 2. Section 9-4.2, Revised Ordinances of Honolulu 1990 (“Disposal charges for businesses and federal, state and city agencies”), is amended by amending subsection (a) to read as follows:

“(a) Unit Charges for Disposal. For the receipt and disposal of refuse and other solid wastes delivered to disposal facilities by any business or any federal or state agency, the following unit charges shall apply:

<b>Disposal Facility</b>	<b>Unit Charge (per ton)</b>	<b>Unit Charge (per cubic yard or fraction thereof)</b>
H-POWER	[\$ 72.25	\$ 22.50]
	<u>\$ 81.00</u>	<u>\$ 25.25</u>
Transfer Stations	[\$ 98.75	\$ 29.00]
	<u>\$110.60</u>	<u>\$ 34.50</u>
Landfills	[\$ 72.25	\$ 22.50]
	<u>\$ 81.00</u>	<u>\$ 25.25”</u>

SECTION 3. Ordinance material to be repealed is bracketed. New ordinance material is underscored. When revising, compiling or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the revisor of ordinances need not include the bracketed material, or the underscoring.






