

A BILL FOR AN ORDINANCE

TO REZONE LAND SITUATED AT HALAWA-PEARL CITY, OAHU, HAWAII
(AMENDING PORTION OF ZONING MAP NO. 7), ORDINANCE NO. 86-133

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION I. Land situated at Foster Village, Oahu, Hawaii, hereinafter described is hereby rezoned from P-2 General Preservation District to R-5 Residential District with a 25-foot height limit. The boundaries and area of said District shall be described as shown on the map attached hereto, marked Exhibit "A-1" and made a part hereof, and further identified as Tax Map Key: 9-9-046:070, Portion.


